## **CHECLIST FOR STOLEN AND / OR HI-JACKED VEHICLES**

-In support of your claim, Insurers will call for the following:

-Fully completed claim form

-A copy of the driver's licence, including front page of ID document

-A clear copy of the original purchase invoice

-Copies of invoices for any non-standard accessories (not appearing on the original purchase invoice), i.e truck load-body, LDV canopy, mag wheels, two-way radios, tachograph units, decals, tow bars). Bull bars etc.

-Immobilizer certificate and / or itemized purchase invoice

-Complete set of keys and immobilizer control. The spare in the case of hi-jacked vehicles

-Where there is a current lease or installment sale (HP) agreement in force, a letter from the financial institution confirming the outstanding balance on the contract.

-SAP clearance form, completed and stamped by the policy station investigating the matter.

-Details of any personal or identifying marks peculiar to the vehicles, which may assist in identifying the vehicle if located.

-The ORIGINAL Cancellation of Registration Certificate issued by the Traffic Department. The Road Traffic Ordinance currently in force requires that this be done within 21 days of the theft. Please let us know if you need advice on procedure, which may vary slightly from area to area.

-Some insurers call for proof of mileage, i.e. copy of last petrol card record, last service invoice etc.
